- 1 After a dozen steps, I began to feel myself sinking into the soft sand. I tried to jump free, but I began to sink deeper. "Oh no! What is happening?" I began to feel frightened and panicky. In seconds, it was up to my knees. I couldn't do anything now. I tried to get up and free myself, but it seemed to get worse. I suddenly realised that I was sinking into quicksand!
- 2 I was shocked. There was nothing on the beach to suggest that it was soft or dangerous. Old fishermen knew very well that the swirling of river or tidal current sometimes dig out empty holes or hollows that are filled with soft sediments like sand. They are believed to have a big appetite, for they have swallowed fishermen, horses and carts, motorbikes, and even dump trucks. But I don't believe that. What I know is that you don't sink in quicksand until you are almost covered up. Humans and animals typically float in water, so if you are standing upright, the furthest you will sink in the quicksand is waist deep. If the quicksand is near a river or coastal area, you can still drown the old-fashioned way when the tide comes in, but you won't choke with a mouthful of sand or mud.

I had also read long ago that farmers who got stuck in quicksand while rounding sheep would spreadeagle, that is, lying with arms and legs spread out. This is to spread your weight so you would not sink immediately. But with the sand up to my thighs, I knew it was too late to work out. "My God, I'm being swallowed," I thought. "The sand is eating me alive!"

3 Yelling for help seemed hopeless. Nobody would hear me. There was no one around. If they were, they would be miles away. Almost in a panic state, I started to imagine myself being choked to death as my nose and throat were filled with sand. I had lost hope. "I'll disappear and nobody will ever know what happened to me."

4 Perhaps if I remained very still, I might delay the slow death. Help might even arrive before it was too late. But I continued to sink; now above my knees, then another centimetre and another. I tried to hold my breath. I then tried to wriggle my toes, but my feet seemed stiff like concrete. Only when the sand climbed to my waist did I stop sinking. Although my body was still motionless, my brain was spinning. And suddenly, I had a frightening thought. "Where is the tide? When will it come in again?"

5 I remembered that the tide was going out when I reached the beach, which meant it wouldn't be back for another nine or ten hours. "I've got a chance after all!" I told myself with relief. Surely, help would come within the next few hours. Or would it? I told myself to remain positive and pray for the best.

6 I still must do something and not just wait for help which might never come. I didn't like the idea of drowning or being swallowed alive. I began to scoop away the sand around my waist. But as fast as I dug, the sand came back into place. After an hour, my fingers were numb and sore, my legs were raging with cramps. I stopped digging.

7 Then I heard a roar like a waterfall. Moments later, there was a downpour. Soaked in seconds, I buried my face in my hands and bowed my head. Trapped in the jaws of sand, there was nothing more I could do.

8 At the first break of dawn, I shouted again for help. I was tired and weak as I became more hopeless. I was worried about the incoming tide. For nine hours, I had been struggling in the sand, motionless, cold and hungry. I tried humming to keep my body warm. There was not a soul to be seen. Still, I kept on shouting and shouting until I lost my voice. What else could I do? I learnt later that my shouting could be heard two miles away.

Mona Fandey

Maznah Ismail, popularly known as Mona Fandey, was a pop singer, witch doctor and a murderer . 27 .

She began her career as a pop singer but was lured by spiritual witchcraft activities. 28 . One such aspiring politician was Mazlan Idris, who wanted to boost his political career using the services of Mona Fandey. Together with her husband, Mohd Nor Affandi Abdul Rahman, and her assistant, Juraimi Hassan, Mona Fandey agreed to help Mazlan. She offered him a strong talisman consisting of a cane and a special headgear, which supposedly belonged to the former Indonesian President, Sukarno. She claimed that the talisman would make him 'invincible'. 29 . Mazlan made a deposit of RM500 000 cash and 10 land titles as surety for the remaining RM2 million.

In order to acquire the talisman, Mazlan had to undergo a cleansing ritual by Mona Fandey. 30 . She then placed flowers all around him. Mazlan was told to close his eyes. 31 . Then, they dismembered his body into 18 parts and buried them in a storeroom in her house in Pahang. This fateful day was 18 July 1993.

After receiving the money, she went on a luxury shopping spree. She bought a Mercedes Benz and had a facelift. However, the police found Mazlan's remains in her house. The trio were arrested on 22 July 1993. 32 . On 2 November 2001, all three of them were hung in the Kajang Prison after their plea for pardon or clemency was rejected by the Pardons Board of Pahang.
